

#### **TERMS & CONDITIONS**

## **Budapest Contest**

# By participating in the game you declare that you accept these Terms and Conditions unconditionally.

- 1. **Organizing Company** The entity organising this contest (the "Contest") is Vacaciones eDreams, S.L.U. (the "Company"), a Spanish limited liability company with registered office in Conde de Peñalver 5, 1° Ext. Izq. 28006, Madrid, Spain and Tax ID Number B-61965778. The Contest is not sponsored by Instagram.
- 2. Location, date and time of the Campaign The game will take place on the Organizer's Instagram account @eDreams from April 26th 2020 at 10 a.m., until May 7th 2020, ending at 12.00 p.m. GMT (hereinafter "Promotional Period"). The winner will be chosen, in accordance with the provisions of these rules, on May 12th 2020, at the registered office of the Organizer.
- 3. Eligibility Any person who meets the following requirements can participate: (1) be at least 18 years of age and (2) reside in the United Kingdom, Germany, Italy, Spain, France and Czech Republic. All employees, partners employees and/or their family members of the eDreams ODIGEO Group (such as Opodo, Go Voyages, Vacaciones eDreams, Liligo metasearch Technologies, Travellink), may not participate in the promotion. Participation is free.

The possibility to participate on the Instagram account @edreams will be accessible from April 26th 2020 at 10 a.m., until May 7th 2020, ending at 23:59 p.m. GMT. The winner will be chosen randomly using Random.org. The decision in all matters relating to this contest are final and binding. 
